I / We hereby instruct Arta Global Markets Limited ("AGML") / Arta Global Futures Limited ("AGFL") to transfer the above-stated amount from the positive cash balance standing in credit to my /our account and held by AGML / AGFL as of this date (less any amount deductible from my / our account by AGML under the Client Trading Agreement between me /us and AGML / AGFL before such transfer), to a bank account opened by Interactive Broker Hong Kong Limited ("IBHKL") with a licensed bank in Hong Kong, where IBHKL will hold (for AGML / AGFL) pre-funding from AGML's clients for purchases to be executed by IBHKL as sub-broker, as well as receipts from transactions executed by IBHKL as sub-broker for AGML / AGFL clients.
